

Shiv Sena (UBT) leader Sanjay Raut on Saturday hinted that his party might go solo in the Brihanmumbai Municipal Corporation (BMC) election without exiting the Maha Vikas Aghadi. Talking to reporters, Raut said party workers were insisting the organisation go solo in the local body polls, as there were more aspirants than for the Lok Sabha or state assembly polls. "Talks are on between March 2022, and fresh polls are due for Uddhav Thackeray and other party leaders nearly three years now.
