# Tree felling: SC says no activity till further orders, asks Telangana to explain compelling urgency

**NEW DELHI, APR 03** 

The Supreme Court on Thursday asked the Telangana government to explain the "compelling urgency" clearing a large tree cover on a land parcel next to University of Hyderabad, and stayed any future activity till further orders.

A bench of Justices B R Gavai and Augustine George Masih, which took suo motu cognisance of the state's tree felling drive in Kancha Gachibowli Forest, called it a "very serious" matter.
